# THE "BAD SCIENCE" FICTION: RECLAIMING THE DEBATE OVER THE ROLE OF SCIENCE IN PUBLIC HEALTH AND ENVIRONMENTAL REGULATION

# I

# INTRODUCTION

Imagine a world in which the proponent of a legal reform bears the burden of showing that a problem exists. Ideally, the reformer would also be expected to produce some evidence that the reform would actually address the identified problem and would not, on balance, make matters worse. In that world, there would be no Shelby Amendment<sup>1</sup> and no Data Quality Act,<sup>2</sup> and professors would not meet to discuss the merits of "Daubertizing" agency science.<sup>3</sup> None of these three "good science" reforms are supported by meaningful evidence that the purported problem—"bad science," or more precisely, science that is methodologically unsound—occurs with any regularity in administrative decisionmaking. The proponents of these reforms are even more hard-pressed to establish that their reforms will not make the science-related problems in public health and environmental regulation worse rather than better. Indeed, existing evidence suggests the former is more likely to be the case.

In this imaginary world in which legal reformers must satisfy minimal, logical prerequisites, this suite of good-science reforms—much less the administrative resources needed to implement them—cannot be justified. While the science underlying existing regulations is hardly perfect, it is far better than it will be once the reform proposals are implemented.

This Article argues that the good-science reforms miss the mark and have the potential to cause significant damage to already crippled administrative processes. Part II presents background information relating to the sources of dissatisfaction with regulatory science and how the three most popular reforms

purport to address these concerns. Part III details the absence of any compelling justification for the reforms, and Part IV discusses why they will be detrimental to agency processes and to the cause of good science. The final part considers the "rebuttal problem"—another way to frame the problem underlying the consternation with the way science is incorporated into regulatory policy. This reframing captures the real dissatisfaction with agency rulemaking, which lies not with the science, but with the absence of clear policy direction as to when a body of science sufficiently rebuts a protective assumption and permits a less stringent standard. Addressing this policy gap will accomplish far more than any of the good-science proposals.

#### Π

# HOW SCIENCE IS INTEGRATED INTO REGULATION

Science teases policymakers with the prospect of providing definitive guidance for regulatory decisionmaking. But in reality, the information that most scientific research provides to health and environmental regulation is incomplete and inconclusive, both in identifying and in quantifying the risks that these hazards pose. This Part considers the ways in which science disappoints and complicates regulatory decisionmaking and identifies the ways in which the good-science reforms hope to overcome these science-based complications.

#### A. The Problems Science Presents to Environmental Regulators

Since science is a necessary but not sufficient ingredient for environmental decisionmaking, it is important to locate "good science" concerns on the larger map of regulatory science problems. "Science" is, according to the Supreme Court, knowledge that can be supported by a "scientifically valid... reasoning or methodology."<sup>4</sup> This generally requires a hypothesis capable of being tested in a replicable way or the use of methods that scientists have generally accepted as valid.<sup>5</sup> Extrapolation from one or more validated scientific studies to a larger policy question—for example, the appropriate standard for a particular pollutant—is typically *not* science, since such "weight of the evidence" judgments cannot be supported by a testable method. Instead, these larger risk assessments combine scientific knowledge (for example, toxicity tests on animals) with science-policy judgments (for example, dose-response assumptions).<sup>6</sup>



Accordingly, most decisions in public health and environmental regulation break down into a series of sub-decisions that alternate or zigzag between science and science-policy.

# FIGURE 1: The Zigzag of Science and Science-Policy In Public Health and Environmental Regulation



Consider, for example, a common issue addressed by regulatory agencies: the appropriate protective standard for a particular pollutant in a specific medium, such as drinking water. The first, overarching question an agency must address when faced with this decision is the amount of human risk the agency (or, often, Congress) is willing to tolerate, a question that is safely outside the realm of pure science. After deciding on a protective goal of, for example, tolerating only one cancer out of every one million persons exposed, the agency's analysis breaks down into a series of discrete questions. Some of these questions can be answered by science alone. Some, however, cannot, and the most that science can do is to point to several of the most plausible options.

Science can, for example, identify the level of high-dose exposure that produces tumors in fifty percent of mice exposed to the pollutant (Q2), but it leaves unanswered how regulators should extrapolate from this type of study to humans. In the absence of definitive human testing, science cannot answer, for example, whether all tumors or only those that are malignant should be counted (Q1), or how to extrapolate from high to low does (Q3) or from animal to man (Q4).<sup>7</sup>

Based on this conceptualization of regulatory decisions as involving a zigzag between science and science-policy questions, we can expect at least three dis-

tinct problems to arise in the incorporation of science into regulation. First, the scientific studies on the top half of the zigzag might be of *poor quality* ("bad science"), or the agency might not include the best science in its analyses.<sup>8</sup> "Bad science" can result from a variety of imperfections in research, from the blatant falsification of data on one end, to imperceptible researcher bias or incompetence on the other.<sup>9</sup> Problems with the quality of science underlying regulations arise if an agency weights these low-quality studies too heavily or ignores or gives insufficient credence to high quality research.<sup>10</sup>

The second regulatory science problem, *transparency*, arises from an agency's failure to explicitly identify the separate roles scientific research and value choices play in reaching a final regulatory decision—that is, failure to identify the specific contours of the science-policy zigzag. The administrative system, which includes judicial review, is grounded in a commitment to provide the public, interest groups, congressional officials, and the President and his staff with an accessible and understandable explanation for regulatory decisions.<sup>11</sup> Since the zigzag nature of science and science policy makes it easy to blur the respective roles of science and policy in regulatory decisionmaking, these political checks and balances can be lost or at least impeded by the complex interweaving of technical and value decisions.<sup>12</sup> Agencies, as technical experts, can even hide controversial policy judgments by failing to delineate the aspects of their decisions determined by science and those determined by value choices.<sup>13</sup>

The third regulatory science problem relates to the production of scientific research, which plays a vital role in anchoring regulation by reducing uncertainties. Since science provides information that is vital to environmental and public health regulations, the regulatory system should not only make the most of available science, but should encourage its production. In fact, however, the production of relevant scientific information during the lifetime of environmental and public health regulation has been unimpressive.<sup>14</sup> Agencies have not established coherent research priorities.<sup>15</sup> At the same time, an agency's regulatory presence discourages the private production of this same scientific information because, from an industry's perspective, producing research on adverse health or environmental effects is as likely to lead to greater regulation as it is to lead to less regulation.<sup>16</sup> Consequently, while there are limits to how scientific information can be used to inform environmental policymaking, even the limited contributions science can make to assessing health and environmental risks are often unavailable.<sup>17</sup>

# B. Enter the Good-Science Reforms

The good-science reforms generally purport to target only the first regulatory science problem described above: the quality of the scientific research underlying regulation. Each of the three reforms (the Shelby Amendment, the Data Quality Act, and regulatory *Daubert*) attempt in different ways to expand peer review and oversight processes to improve the checks on what is feared to be regulatory research of poor quality.<sup>18</sup>

The first good-science reform, the Data Access Amendment (also known as the Shelby Amendment), provides regulatory participants with access to the data underlying studies produced with federal money.<sup>19</sup> Although passed as a rider with little legislative history or debate,<sup>20</sup> this reform appears to be intended to enhance the quality of regulatory science by providing regulatory watchdogs with data they can use to validate the conclusions of researchers.<sup>21</sup> The proposed data access guidelines generated a great deal of controversy within the scientific community, and over 12,000 comments were submitted.<sup>22</sup> In response to these comments, the Office of Management and Budget ("OMB") provided additional protections for researchers in the final 1999 Guidelines, including limiting access only to the data underlying "published" studies, providing researchers with a "reasonable amount of time" to assemble the requested data, and providing mechanisms for agencies or researchers to recover reasonable costs associated with responding to information requests.<sup>23</sup>

The second reform, the Data Quality Act, was similarly passed as an appropriations rider without hearings or public debate.<sup>24</sup> The Data Quality Act

("DQA") requires agencies to establish a process by which parties can lodge petitions for the correction of information, including scientific studies, disseminated by the agency.<sup>25</sup> This petition process places interested parties in the role of peer reviewer. They can allege, through a formal process, that a study should be excluded from regulatory decisionmaking because it is too unreliable to be useful, an allegation taken more seriously if the study plays an "influential" role in a policy decision.<sup>26</sup> Disgruntled complainants whose requests for correction are denied can file an appeal with the agency.<sup>27</sup> It is also expected that complaints and requests for correction will carry some weight if an agency action is challenged in court and that they might even be appealable in and of themselves under limited circumstances.<sup>28</sup>

The third reform, regulatory *Daubert*, which is still in the proposal stage, appears to expand peer review beyond that provided by the Data Access Amendment and the Data Quality Act by employing the courts, rather than agencies, to preside over disputes concerning the quality of regulatory science.<sup>29</sup> The regulatory-*Daubert* proposal appears to entrust appellate judges with the gatekeeping responsibility of determining de novo whether a study is sufficiently reliable to be included within a larger regulatory model or decision-making context.<sup>30</sup>

A final set of recent developments are more ad hoc, but nevertheless deserve mention because they also arose as apparent reactions to concerns that "bad science" was being used by the Environmental Protection Agency

under the APA. ("EPA"). Both *Chlorine Chemistry Council v. EPA*,<sup>31</sup> in which the D.C. Circuit remanded EPA's chlorine standard for drinking water, and the Bush Administration's temporary suspension of the arsenic standard for drinking water<sup>32</sup> suggest shifts towards tolerating greater risks than EPA is willing to accept. But they are also framed as agency failures to use "good science."<sup>33</sup> While these reforms are too ad hoc to provide much material for the analysis presented in Parts III and IV below, they will form an important part of the discussion presented in Part V of the *real* problem with the role of science in regulatory policy.

#### III

# ASSESSING THE REFORMS

Intelligent efforts to reform regulation anticipate how those efforts might be distorted by agency over-reaction, judicial overreaching, or imbalances in the resources of various interest groups.<sup>34</sup> Complex administrative forces can transform even simple and sensible reform proposals into hopeless bureaucratic processes that lead to results quite different from what is expected.<sup>35</sup>

Before tinkering with agency processes, then, it is imperative that we do our homework. First, we must describe with some precision the problem that is being addressed. Taking this simple step will ensure that there are real benefits to be gained that outweigh the risks associated with disturbing the status quo.

Second, we must anticipate how reform proposals will fare once introduced into the complex regulatory system.

Despite the potential intrusiveness of the good-science proposals, however, little of this homework has been done. There have been only a few general references and anecdotal accounts of agencies using or producing bad science in the area of environmental and public health regulation. Moreover, these cumulative accounts provide, at best, only sparse evidence of a problem and offer no evidence that the problem is a significant one.<sup>36</sup> Still more troubling, virtually no attention has been given to tracing these proposals through the agencies to determine the types of unintended administrative reactions they are likely to produce.

The next two sections consider these questions, even though the recent implementation of two of the three reforms under discussion might make such an ex post analysis academic.

# A. In Search of Bad Agency Science

After more than thirty years of vigorous public health and safety regulation, it seems almost inevitable that an agency would have relied upon a scientific study that ultimately proved unreliable. Yet, despite the thousands of public health and safety regulations promulgated annually,<sup>37</sup> there are surprisingly few examples of EPA using unreliable science or using science inappropriately to support a final regulation.<sup>38</sup> This assessment might be far different if one con-

sidered the larger universe of regulatory decisions involving the grant of permits and licenses, since these decisions rest in large part on unvalidated industry science. Indeed, to the extent that a "bad science" problem has been identified in regulatory decisionmaking, it concerns the quality of science produced by regulated parties for purposes of regulation.<sup>39</sup> Once this private science is excluded, the examples of regulatory bad science are winnowed down to a few, virtually all of which are contested.<sup>40</sup>

Commissioned expert reports provide the most credible resource for assessing the quality of EPA's science. These reports identify very few problems with the quality of the agency's science, and the problems that are identified are relatively minor. In the first major report on the topic, *Safeguarding the Future*, commissioned by EPA in 1992, the expert panel found that EPA was *perceived* to fit science to policy, but the experts were notably silent as to whether this perception was accurate.<sup>41</sup> Most of the findings and recommendations contained in the report urged EPA to do more to validate its analytical models and assumptions, strengthen its peer-review system, and increase the number of capable scientists employed at the agency, although EPA's shortcomings in these areas did not appear significant.<sup>42</sup> Although the panel did find that scientific advice should be integrated earlier and more often into EPA decisionmaking, none of the eleven major findings of the study suggested that the

agency used bad science in its decisionmaking.<sup>43</sup> Eight years later, the National Academy of Sciences ("NAS") released a report entitled *Strengthening Science at the U.S. Environmental Protection Agency*, which offered even more tepid criticisms of the quality of EPA's science.<sup>44</sup> Much of the NAS report offered recommendations for how EPA could improve scientific leadership at the agency, enhance the production of information, and anticipate future environmental needs through scientific research.<sup>45</sup> Only one section was dedicated to the quality of the science actually being relied upon, and in this section the authors complimented EPA for improvements to its peer-review system, but maintained that still more independence was needed between project managers and the peer-review process.<sup>46</sup> One certainly cannot conclude from these reports that EPA produces or relies upon bad science to support its decisions.<sup>47</sup>

Congressional hearings and NAS workshops on the Data Quality Act also fail to provide examples of poor quality science emerging from the agency.<sup>48</sup> The attachments in one congressional hearing, in fact, provide a veritable library of studies conducted on the quality and rigor of EPA's science practices.<sup>49</sup> None of the several dozen reports in this two-volume, 2,400-page set

provide evidence of EPA using biased or bad science. To the extent that problems were found with EPA's science, they again arose in the management of scientific research, in EPA's strategic plans for that research (including the implementation of those plans), and in peer-review practices.<sup>50</sup>

A small yet robust literature by academics and policy analysts similarly suggests that there is little evidence of bad science used to support regulatory decisionmaking. In fact, some of these analysts conclude that agencies do a relatively competent job of assessing the methodological rigor of the science they incorporate into regulatory decisionmaking. Ted Greenwood, Sheila Jasanoff, Mark Powell,<sup>51</sup> and Bruce Smith each conclude in four separate, book-length examinations of the science at EPA, the Occupational Safety and Health Administration ("OSHA"), and the Food and Drug Administration ("FDA") that these agencies are relatively adept at locating relevant science and evaluating the quality of the various scientific inputs in the course of their decisionmaking.<sup>52</sup> While all four authors observed that the regulatory programs under

study were not free of problems, they did not identify the agencies' scientific competency as being among them.<sup>53</sup>

Most curious in a search for the bad-science problem is the failure of the reformers themselves to document a problem. The literature supporting the Data Access Amendment, both before and after passage, provides only a few, limited examples of problems with regulatory science or access to data.<sup>54</sup> Discussions of the problems the Data Quality Act is intended to solve are sparser still: only a few secondary articles, all published after passage of the Act, provide examples of agencies relying on or disseminating poor-quality science.<sup>55</sup> Regulatory-*Daubert* proponents similarly fail to produce evidence of the "bad science" problem. For example, in their thoughtful analysis in this Symposium, Alan Raul and Julie Zampa Dwyer identify the lack of transparency of agency policy judgments as the primary problem with science-based regulation. Concerns about the scientific quality of studies and analyses used in regulation, by contrast, are only weakly supported and seem secondary in their analysis.<sup>56</sup>

Other parties committed to reforming the bad-science problem similarly take its existence for granted. One of the main proponents of both the Data Quality Act and the Data Access Amendment, the Center for Regulatory Effectiveness, provides virtually no evidence to support its assumption that a bad-science problem exists, although the Center does take issue with agency policy choices in extrapolating from science to regulatory policy.<sup>37</sup> In its oversight of the rigor and cost-effectiveness of agency rulemakings, OMB has neglected to provide examples of agencies using bad science, although presumably the systematic collection of examples of this problem will be one of the benefits of the Data Quality Act.<sup>58</sup> The only apparent effort to document an underlying problem with the quality of agency science comes from a series of sharp critiques posted on a "junk science" Internet site.<sup>59</sup> Again, however, virtually all of the essays take issue with the agencies' protective policies (in the bottom half of the zigzag mapped at Figure 1), rather than with the quality of the research (in the upper half of the zigzag).<sup>60</sup>

Even the poster-child for the good-science reforms—the "Six Cities" study conducted by Harvard's School of Public Health—undermines, rather than supports, the need for comprehensive reform of the quality of agency science.<sup>61</sup> The Six Cities study was very controversial among the regulated community because its findings regarding the risks posed by fine particulates were influential in EPA's decision to lower the particulate standard under the Clean Air Act.<sup>62</sup> Industry requested the original data supporting the study, but the Harvard researchers refused because they were concerned that even the redacted data could be used to identify original study participants who were promised confidentiality.<sup>63</sup> After considerable controversy, EPA hired the Health Effects Institute ("HEI") to perform a re-analysis of the study while keeping the data confidential. "The HEI found the original data to be of high quality, and essentially confirmed the validity of the original findings and conclusions."<sup>64</sup>

# B. Institutional Checks and Balances

Of course, one need not insist upon tangible evidence of bad regulatory outcomes to be convinced that there is a problem with the quality of the science underlying regulation. Agencies might have numerous reasons to rely on weak or valueless studies to support regulation. For example, either low-level staff or micro-managing, high-level administrators with political objectives might have both the incentive and opportunity to commission or combine studies that lead to a predetermined result. Malaise and inattention might also cause agency staff to include in their analyses studies that are not sufficiently scrutinized. The sheer size of administrative records supporting many environmental and public health standards lends credence to this possibility.<sup>65</sup>

As discussed in detail below, however, it appears that even if these bureaucratic forces prevail at the expense of good science in some rulemakings, multiple internal and external checks on agency science provide reason for optimism that this abuse is not pervasive. These checks help correct deliberate and inadvertent errors and deter agencies from relying on science that is methodologically unsound. Such checks might explain why there are not more specific accounts of agencies abusing their technical powers by relying on bad science.

Science advisory boards and related expert panels provide the most obvious check on the unbridled freedom of agencies to promulgate regulations based on

bad science.<sup>66</sup> Professor Sheila Jasanoff and Dr. Bruce Smith both provide a very detailed account of the involvement of scientific advisory boards in the agencies' use of science and conclude that this involvement, at least as of fifteen years ago, generally reinforces the agencies' scientific competency.<sup>67</sup> The expert panel commissioned by EPA for the *Safeguarding the Future* report noticed the same positive effect of the Clean Air Scientific Advisory Committee ("CASAC"), created to review EPA's national ambient air quality standards

("NAAQS").<sup>68</sup> Science advisory boards, however, require time and resources,<sup>69</sup> can intrude on value decisions that are properly reserved for Congress and the agencies (because of the blurred boundary between science and policy),<sup>70</sup> and are not always representative of a cross-section of the scientific community.<sup>71</sup> As a result, science advisory boards cannot be involved in every science-related agency action, although figures from the early 1990s suggest that EPA's Science Advisory Board conducted more than seventy reviews (of varying size) per year.<sup>72</sup>

Courts also provide valuable oversight of the quality of agency science through their review of rulemakings and by ensuring that interested parties have an opportunity to comment on proposed regulations.<sup>73</sup> Although the

approach taken by the courts in resolving disputes over agency science is varied, the threat of a challenge and possible invalidation of a rule is ever-present.<sup>74</sup> This threat presumably deters agencies from committing significant scientific errors.<sup>75</sup> Indeed, it is plausible that agencies plan around a worst-case scenario for judicial review, rather than some "mean" level of judicial scrutiny.

Periods of embarrassing congressional oversight are also capable of encouraging agencies to get the science right the first time. These additional checks are more sporadic than science advisory boards and judicial review, but might nevertheless be important.<sup>76</sup> Congress' frequent use of the NAS to review the work of agencies likely provides the most valuable congressionally imposed check on the quality of agency science, however.<sup>77</sup>

A fourth check against bad regulatory science is the hodge-podge of internal review mechanisms agencies have imposed on themselves.<sup>78</sup> Prior to passage of

the Data Quality Act, EPA had already developed four separate programs dedicated to ensuring the quality of information relevant to regulation, including an electronic error correction system.<sup>79</sup> Other agencies have similar programs in place.<sup>80</sup> These formal mechanisms are supplemented by more informal bureaucratic forces that reward the use of good science and penalize agency officials for relying on science of low quality. For example, the diversity of goals and political affiliations of agency staff might create internal checks and balances that protect against the use of low quality scientific studies to advance political ends.<sup>81</sup>

highly influential, such as an assessment of the toxicity of dioxin or the effects of particulates on public health, receive the highest level of review, including several levels of both internal and external peer review.

Finally, scientific norms provide their own powerful check on the quality of regulatory science.<sup>82</sup> "Pathbreaking claims, such as the discovery of high-temperature superconductivity or 'cold fusion,' generate immediate attempts to dissect and replicate the claimed results, both before and after formal publication. Deception and error, scientists plausibly argue, are virtually impossible to maintain in such an atmosphere."<sup>83</sup> While only a few studies, such as the Six Cities Studies, might generate such a high level of interest among health and environmental scientists, these are precisely the studies most in need of validation.<sup>84</sup> At the same time, professional rewards-prestige and publications in prominent, peer-reviewed journals—are generally meted out only when a scientist does good work.<sup>85</sup> Evidence or even allegations that a scientist has violated a critical scientific norm can mark the end of his career.<sup>86</sup> If anything such internal policing within the scientific community might be too inflexible and insular.87 Regardless, it is not surprising that the legal community ignores these professional norms and assumes that legally-mandated requirements are needed to ensure the quality of scientific research and science-based decisionmaking.<sup>88</sup>

#### C. Generous Mandates and Loads of Discretion

Perhaps most pertinent, but generally ignored in the assessment of the quality of agency science, is the limited extent to which agencies must produce scientific studies in the first place to justify regulatory programs. If definitive science is not required as a prerequisite for regulation, that might explain why agencies do not appear to be making significant errors in the science they do use.

Most of the protective statutes were passed with the explicit purpose of bypassing heavy burdens of proof and allowing agencies to regulate on the basis of limited scientific evidence.<sup>89</sup> The possibility of certain catastrophic harms, such as mass exposures to toxic substances, makes this precautionary approach economically rational in many situations.<sup>90</sup> The most familiar example of precautionary regulation is the Delaney Clause, which requires the Food and Drug Administration ("FDA") to ban a food or color additive if a single study shows that the additive causes cancer in animals.<sup>91</sup> Many of the mandates governing EPA similarly require only limited scientific evidence to justify regulatory intervention, although they generally require more evidence than the Delaney Clause.<sup>92</sup> Agencies, in other words, are expected to promulgate protective regulations without a great body of scientific information as a prerequisite.

Examples of this light-to-medium scientific burden for protective regulations run through many of the major environmental and public health statutes. Because Congress specified the hundreds of hazardous pollutants in need of regulation in the Clean Air and Clean Water Acts ("CAA" and "CWA," respectively), EPA needs no scientific evidence of harm and hence almost no scientific studies before promulgating technology-based standards under those statutes.<sup>93</sup> Neither is a great body of scientific evidence needed to regulate nonhazardous pollutants under the CAA.<sup>94</sup> Judge Williams of the D.C. Circuit has

in fact suggested that the statute presumes a protective zero-standard for nonthreshold pollutants under section 109.95 Judge Williams presumably would have held similarly under the Safe Drinking Water Act challenge to EPA's chlorine "maximum contaminant level goals," except that the science was more comprehensive for chlorine and suggested that the presumptive zero-standard was rebutted.<sup>36</sup> EPA, with approval from the D.C. Circuit, interprets the Federal Insecticide, Fungicide, and Rodenticide Act ("FIFRA") to allow uncertainties regarding the safety of a pesticide to be resolved against the pesticide, so that the agency can proceed to ban pesticides without definitive evidence of toxicity.<sup>97</sup> Finally, the Resource Conservation and Recovery Act ("RCRA"),<sup>88</sup> the Comprehensive Environmental Response, Compensation, and Liability Act ("CERCLA"),<sup>99</sup> and the Environmental Planning and Community Right-to-Know Act ("EPCRA")<sup>100</sup> require merely the presence of one of hundreds of nasty substances to trigger a rather overwhelming set of regulatory and liability requirements.<sup>101</sup> While EPA needs some scientific evidence to justify categorizing a substance as one of the regulated hazardous wastes or

substances under CERCLA, EPCRA, and RCRA,<sup>102</sup> the evidence need not (and in any case, cannot) be complete or definitive.<sup>103</sup>

#### IV

# THE GOOD-SCIENCE REFORMS THREATEN TO MAKE MATTERS WORSE RATHER THAN BETTER

Even if evidence that agencies actually rely on flawed science is scant, there is perhaps no harm in imposing additional checks to ensure that their science is sound. In the case of the good-science reforms, however, it is quite possible<sup>104</sup> that the reforms will have a significant adverse impact on the quality, quantity, and transparency of agency science and on the cost and accessibility of the administrative process more generally. Both sets of "worst case" effects are detailed in turn.<sup>105</sup>

## A. The Agency Science Problems Might Be Made Worse Rather than Better

Although the idea behind the reforms is to improve the quality of the science that undergirds regulation, it seems quite possible that precisely the opposite will happen. Agencies might avoid disseminating or relying on scientific

information whenever possible. High-quality scientific research could be lost to the strong forces of politically motivated deconstruction,<sup>106</sup> and the already dampened incentives for the production of public health and environmental research will be further reduced.

1. Shrinking the Pool of Scientific Studies Available to Justify Regulation

a. Reducing the number of studies disseminated or used in regulation. The most devastating result of the good-science reforms is their potential for converting science from the agencies' friend to their enemy.<sup>107</sup> Agency risk assessments that rely on cutting-edge studies will be rewarded with bothersome Data Quality Act complaints, requests for data access, and potential challenges under regulatory *Daubert*.<sup>108</sup> Agencies might find that incorporating or even publicizing recent scientific discoveries in the course of their regulatory duties is a losing proposition since it opens them up to unending attack under the good-science laws.<sup>109</sup> As a result, the dissemination and use of cutting-edge science

might itself become "ossified" in the administrative process.<sup>110</sup> Scientists might also be reluctant to share the results of path-breaking studies with agencies for fear of having their research tarnished by good-science complaints.<sup>111</sup>

To the extent that an authorizing statute permits protective regulation with little science, the good-science reforms might also encourage agencies to make regulations on as thin a scientific record as possible.<sup>112</sup> Agencies already appear poised to avoid identifying scientific studies as "influential" since this invites more burdensome "reproducibility" requirements under OMB's Data Quality Guidelines.<sup>113</sup> Agencies might not only downplay influential studies; they might downplay scientific studies altogether, relying instead on "policy choices" and other discretionary bases for decisions.<sup>114</sup>

Certain types of studies might be especially vulnerable to challenges under the good-science reforms and could consequently be under-utilized by the agencies.<sup>115</sup> The first are meta-analyses and mechanistic models that link distinct

databases or research findings together to derive a more holistic picture of an ecological or public health problem.<sup>116</sup> These unconventional but much-needed forms of analysis are replete with features vulnerable to challenge relative to standardized, individual studies.<sup>117</sup> To avoid such challenges, an agency might opt for less ambitious models, studying each hazard as narrowly and simply as possible.<sup>118</sup> Rather than combating agencies' tendency toward reductionist analysis, then, the good-science reforms might encourage it.<sup>119</sup>

The second category of studies vulnerable to attack under the good-science reforms are those that pertain to especially controversial regulations. Even without the good-science reforms, an influential study like the Six Cities Study would receive a great deal of attention from the scientific and regulatory communities because of its significance to public health and the economy.<sup>120</sup> This type of controversial study will likely receive only that much more extended vetting under the good-science reforms. Indeed, if the data access and data

quality reforms had applied at the time, the Six Cities Study might still be mired in access requests, complaints, and re-analysis studies, some of which would challenge peripheral, technical features of the study that would require detailed agency responses.<sup>121</sup> Although agencies *might* be able to forge ahead and promulgate rules based on such contested studies,<sup>122</sup> the wiser course would be to wait for the controversy to resolve itself or to avoid controversial studies or rulemakings altogether.<sup>123</sup>

Finally, increased procedural requirements for agencies' use of science might cause them to become more resistant to using science in their public outreach efforts.<sup>124</sup> Data Quality Act requirements might also cause agencies to refrain from policing the quality of information in the public domain, such as bad information disseminated by private parties.<sup>125</sup> Under such a regulatory process, minimizing agency encounters with technical information is the optimal survival strategy.

b. Discouraging the production of science. Another worrisome effect of the good-science reforms is the subtle shifting of the burden of producing and then defending science from industry to agencies. Scientific research offers valuable information for environmental decisionmaking, and although the limits of science prevent us from obtaining complete answers, there are a number of questions for which our ignorance is remediable. Despite this fact, over the past thirty years, our scientific knowledge regarding public health and environmental harms has advanced very little. We still have no accepted way of evaluating damage to ecosystems<sup>126</sup> or of inexpensively testing for neurological and

developmental harms in laboratory animals (or humans).<sup>127</sup> We have shockingly little baseline data about environmental quality.<sup>128</sup>

Nevertheless, the good-science reforms zero in on the few studies that have been done and suggest that they be done better,<sup>129</sup> in spite of the limited federal support for environmental research<sup>130</sup> and a growing recognition that research

on environmental problems is under-produced by private parties.<sup>131</sup> Rather than financing *more* studies, scarce resources will be spent debating the quality of the handful of studies that have been done.<sup>132</sup>

By contrast, the private sector can avoid regulation simply by resisting the production of valued research.<sup>133</sup> There is little incentive for a regulated entity to invest in voluntary research that could produce results that not only lead to more stringent regulatory requirements,<sup>134</sup> but that could impair, rather than improve, the marketability of its products.<sup>135</sup>

Finally, a number of commentators have expressed concern about the effects of the good-science reforms on scientists themselves.<sup>136</sup> Both the American Association for the Advancement of Science ("AAAS") and the NAS have

expressed their concern that the Data Access and Data Quality Acts could be used to harass scientists and discredit good research.<sup>137</sup> Preliminary experience with these reforms lends credence to these concerns.<sup>138</sup> It is also possible that the threat of these challenges could discourage scientists from undertaking research on issues relevant to regulation. Threatening letters recently sent to academic institutions by an industry-funded nonprofit, the Center for Regulatory Effectiveness ("CRE"), warning them to adopt procedures to comply with the Data Quality Act, only serve to reinforce fears that the good-science reforms might be used to intrude on scientific freedom.<sup>139</sup> The costs imposed on

scientists' time and reputations by the good-science reforms could ultimately deter the most ambitious scientists from research that has any bearing on policy. Again, this result seems to be precisely the opposite of what is sought by the good-science proponents.

2. The Quality of Regulatory Science Might Be Impaired Rather than Improved

a. A dysfunctional peer-review process. The good-science reforms are expected to improve the quality of science by expanding peer review to a larger circle of interested parties, including those who have a stake in the outcome of studies that inform regulation.<sup>140</sup> But this approach is the antithesis of the way that science is supposed to operate.<sup>141</sup> Scientific peer review is supposed to consist of unbiased external review by those trained in the scientific method.<sup>142</sup> Over the years, there has been considerable discontent with the peer-review process, much of it related to concern over the lack of objectivity of those doing the reviews. Even matters as seemingly insignificant as the affiliation or fame of the researcher can affect the outcome of peer reviews.<sup>143</sup> These concerns do not portend well for extending peer-review responsibilities to biased regulatory participants. An expanded peer-review process conducted by those with the high-

est stakes in the outcome is not likely to improve the quality of the scientific research.<sup>144</sup> Instead, resourceful stakeholders will make mincemeat of virtually every regulation-relevant study they find distasteful.<sup>145</sup> As Professor Jasanoff observes: "The most obvious source of bias in the regulatory environment... arises from the fact that expert referees may either be formally affiliated with particular interest groups or otherwise have a stake in the outcome of the regulatory process."<sup>146</sup> Good science is unlikely to result from this bad process of peer review.<sup>147</sup>

Even the *Daubert* reform, which employs the courts as the penultimate gatekeeper of the quality of agency science, seems destined to impair, rather than improve, the quality of agency science.<sup>148</sup> History has shown, in part from the inadequacy of the *Daubert* opinion itself, that the courts are unsuccessful in defining "good science" with any precision or in serving as rigorous reviewers of agency science.<sup>149</sup> Moreover, in contrast to the agencies, judges have neither the

information nor the expertise to competently adjudicate challenges to the quality of agency science.<sup>150</sup> Still more curious, it is not clear what oversight role the courts are being asked to play. As Professor Pierce has pointed out in recent commentary, while the reasons for the courts' gatekeeping role in jury trials are apparent, it is not clear why appellate courts, rather than agencies, are making choices about which studies are unreliable. The courts are certainly not ensuring that the science is sound so that some other, less expert party, like a jury, can rely on it. Yet if the courts' scientific competency is less than that of the party they are reviewing, it is unclear what the courts are contributing to the exercise.<sup>151</sup> In all likelihood, as is borne out in past cases, the courts will either rubberstamp agencies' science or undertake a searching review.<sup>152</sup> Neither is likely to provide a valuable contribution to agency decisionmaking. In those instances in which courts have undertaken searching reviews of agency science, their opinions often reinforce rather than allay concerns about judges' scientific competency.<sup>153</sup> The possibility of judges introducing their own biases through such a process presents yet another significant risk.<sup>154</sup>

b. Exempting industry data from the good-science requirements. Ironically, the good-science reforms target federally funded research and exempt a large body of private science used extensively in licensing and permitting decisions.<sup>155</sup> The reforms thus leave untouched much of the regulation-relevant science that has historically been the most problematic in terms of fraud and bias.<sup>156</sup> The Data Access Amendment requirements apply only to federally funded research that supports a federal action.<sup>157</sup> The DQA requirements apply only to science that is "disseminated" by an agency,<sup>158</sup> and they appear to exempt studies produced by a company to support an application to market a product or obtain a pollution permit.<sup>159</sup> OMB has also interpreted the term "dissemination" to exempt "public filings," which could encompass industries' documentation of compliance with the environmental laws, including the basis for their Toxics

Release Inventory estimates submitted under EPCRA.<sup>160</sup> Together, these DQA exemptions seem to insulate virtually all mandated industry research from the good-science requirements.

Broad exemptions of industry information are reinforced by protections available through trade secret law and confidential business protections.<sup>161</sup> OMB honors these protections in defining the types of science that can be subject to challenge, despite the fact that the universe of confidential information appears much larger than is justified by the actual risks to intellectual property.<sup>162</sup>

It is perhaps even more illogical that the DQA requirements, which are designed to root out biased science, do not require disclosure of the institutional affiliation or source of funding for studies or critiques prepared by interested parties.<sup>163</sup> Thus one, albeit imperfect, proxy for ensuring objectivity in research that is used by most scientific journals—scientist affiliation and funding—is omitted in a law that purports to make scientific objectivity a primary goal.<sup>164</sup>

### B. Harm to Administrative Processes

Good-science reforms are not only capable of impairing, rather than improving, the quality of science underlying public health and environmental

regulation; they also threaten to impair statutory and administrative processes more generally. By imposing new procedural requirements on agency use of scientific evidence, the reforms might conflict, either directly or indirectly, with agencies' statutory mandates that they act expeditiously and err on the side of health and the environment. Refocusing regulatory deliberations on technical minutia, such as the methodological rigor of individual scientific studies, could also alienate the attentive public, who have neither the resources nor the expertise to engage in these reductionist battles that impact regulatory policy in important but subtle ways. Finally, the reforms could drain scarce agency resources without any perceptible benefit to the quality of regulatory outputs.

#### 1. Conflict with Statutory Mandates

The good-science reforms might undercut the ability of agencies to set protective standards pursuant to their statutory mandates in a variety of ways. In some settings, the good-science reforms might directly conflict with an agency's mandate. For example, to the extent that Congress explicitly requires EPA to consider all "available information" in promulgating protective standards, the exclusion of studies under the good-science reforms conflicts with EPA's mandate.<sup>165</sup> Similarly, when Congress 'commands EPA to protect the public health from the release of hazardous substances under the Superfund statute, it explicitly directs that disagreements over the quality of EPA's science be set aside until after cleanups are completed.<sup>166</sup>

The reforms might also be read to suggest that, contrary to authorizing statutes, a few studies are not enough to justify regulation, or that each sciencepolicy or "default judgment" in a risk assessment must be backed by scientific support.<sup>167</sup> A number of the petitions filed under the Data Quality Act have challenged policy choices made at these default junctures.<sup>168</sup> If these challenges

are successful, they could effectively halt protective standard-setting by requiring a definitive body of research as a prerequisite to regulation.<sup>169</sup>

Finally, the good-science requirements could be read to limit the studies that can be considered in regulatory decisionmaking. In a recent complaint filed under the DQA, for example, affected industries argue that EPA cannot consider studies published by researchers at Berkeley in assessing the risks of the herbicide Atrazine because the studies were not done pursuant to protocols validated in advance by the agency.<sup>170</sup> If the industry's DQA complaint is successful,<sup>171</sup> the good-science reforms will have transformed a statute that places the burden on industry of showing that pesticides are safe<sup>172</sup> into a statute that not only places this burden on EPA, but requires that research undergo a centralized approval process before it can inform regulation.

The effects of regulatory *Daubert* on agencies' ability to promulgate protective standards are less clear, but one strain of the proposal could cause even greater conflict with the protective mandates by essentially barring protective standards altogether. In a subset of tort cases in which *Daubert* has been applied, the courts have made de novo judgments about whether a plaintiffs' scientific evidence, in total, provides a "sufficient" basis to meet the "more probable than not" standard of causation.<sup>173</sup> When judges decide that the weight

of the evidence does not support a finding of causation, they exlcude the expert testimony under *Daubert*. Some courts have also applied *Daubert* and concluded that animal studies are insufficient to create a jury question on causation, in part because they are an unreliable way of determining potential harm to humans.<sup>174</sup> If appellate courts use these cases as precedent for applying regulatory *Daubert*, they could also exclude most of an agency's basic studies, thereby undercutting the commands of the precautionary legislation.<sup>175</sup> Even if regulatory *Daubert* is implemented in a more innocuous fashion,<sup>176</sup> challenges could still divert agency resources and slow the standard-setting process.<sup>177</sup>

2. Eliminating Participants and Skewing Review Toward Those with the Highest Stakes

The good-science reforms offer new procedural tools for regulatory overseers (loosely referred to as "the public") to challenge the science underlying regulation; yet because these tools require considerable expertise from users, they are effectively available to only a small set of attentive regulatory participants.<sup>178</sup> The resources needed to employ these tools, in terms of both scientific

expertise and resources, will exclude most attentive regulatory participants. It is thus no surprise that a majority of the DQA petitions filed to date have been submitted by regulated industries or their advocates.<sup>179</sup>

To the extent that participation is skewed towards those who have both a vested interest in the outcome of the regulatory project and a high level of expertise and resources (namely, regulated industry), the reforms will be used

whether political or economic, based on whether there are net benefits to participating, and thus the extent of an individual's participation is based on the difference between the benefits that will accrue to the person by participating and the costs of participation). Not surprisingly, the good-science reforms are the brainchild of regulated industry. See, e.g., NRC, DATA ACCESS REPORT supra note 54, at 2 ("Industry and regulated communities supported the [Data Access Amendment] as a fair way to challenge scientific studies that support costly regulations, tort suits, and dubious/questionable risk estimates. The scientific community opposed the amendment."); supra note 24 (discussing industry's role in drafting the Data Quality Act).

The implications of the Data Quality Act for state regulation and federalism is intriguing, but appears unexplored. Theoretically, if there were a problem of bad regulatory science, it would be just as pervasive in state regulation. only to combat perceived problems of over-regulation.<sup>180</sup> If science has been misused in ways that under-protect the public, there might not be sufficient public-interest advocates with the resources and expertise to catch the problem.<sup>181</sup> Even if public advocates were plentiful, however, challenges to the science underlying regulation only serve to delay protective standard-setting, thus forcing these advocates to choose between the lesser of two evils—unjustifiably delayed standards and unjustifiably weak standards.<sup>182</sup>

Well-heeled participants might not only use the reforms legitimately, but also illegitimately, and in ways that harm the public interest.<sup>183</sup> Petitions against

the quality of an agency's science, for example, can be filed at any time, by anyone, and can include as many complaints and challenges (including those directed at the agency's policies) as the petitioner desires. There are no meaningful costs or sanctions for filing meritless complaints under the DQA or for requesting data and re-analyzing it in problematic ways under the Data Access Act.<sup>184</sup> In contrast, the benefits of abusing these provisions can be considerable to private parties; at best, they can lead to the exclusion or discrediting of pivotal studies that undergird protective regulation, and, at worst, they can divert an agency's resources and priorities away from developing protective policies.<sup>185</sup>

Perhaps more damaging than the fact that only an elite group is able to benefit from the reforms is the potential for the reforms to be used, intentionally or inadvertently, to distance or even exclude attentive participants from regulatory deliberations. These means of exclusion are subtle, but potentially of great significance. First and most pervasive, by focusing rulemaking controversies on the detailed and often arcane methodological features of individual studies—rather than on the much more significant policy decisions that fill the large gaps that science leaves behind—environmental regulation is portrayed as being predominantly about science, and, even more misleadingly, about the details of individual studies.<sup>186</sup> Virtually every DQA complaint filed to date exemplifies this type of covert attack on agency precautionary policies under the charade of a challenge to bad science.<sup>187</sup> Indeed, in the course of responding

to incremental DQA complaints, often filed on individual studies without any statutory reference point, agencies may find themselves making important policy decisions under the inauspicious cover of a DQA challenge.<sup>188</sup> Thus, the good-science reforms can be strategically used to obfuscate the pivotal role that policy, rather than science, plays in environmental decisionmaking and preclude broader public interests from weighing in on what, at bottom, are fundamental policy decisions.

Additionally, by suggesting that current regulations are based on "bad science," the good-science reforms can further erode public trust in agencies and the work they do.<sup>189</sup> Studies have shown that trust is asymmetrical: it is easy to lose and hard to gain back.<sup>190</sup> By implementing reforms premised on the proposition that agencies are unable to use science wisely, the reforms needlessly destroy faith in the regulatory process.

#### 3. Increasing Administrative Costs

Although it is difficult to predict at this early stage how costly implementation of the good-science reforms will be, the costs could be very high.<sup>191</sup> Both the data access and data quality reforms necessitate elaborate record-keeping<sup>192</sup> and raise a number of unresolved and potentially litigious questions, some of which are already presenting themselves in the courts.<sup>193</sup> The high level of scien-

tific activity within agencies like EPA and OSHA also provides ample opportunity for regulatory critics to file correction requests, gain access to and re-analyze data, or otherwise engage agencies in time-consuming bureaucratic reviews.<sup>194</sup> Although to date the DQA complaints appear to be surprisingly few, most of the filings are technically detailed and attack the most important regulatory projects.<sup>195</sup> An industry-sponsored organization even filed a twelve-page preemptory letter warning EPA that it *would* file a DQA complaint if the agency relied on comments submitted by an environmental organization.<sup>196</sup> The absence of deterrents for nonmeritorious DQA complaints and unnecessary data access requests,<sup>197</sup> moreover, makes abuse of process essentially costless.<sup>198</sup>

The costs of the *Daubert* proposal are even more difficult to predict because the proposal itself is unclear,<sup>199</sup> but since all of its variations increase the scrutiny of—and, hence, the extent of litigation over—agency regulatory activities, the regulatory-*Daubert* reform could be exceedingly costly.<sup>200</sup> If the appellate courts essentially conduct the equivalent of *in limine Daubert* hearings on challenged science, the costs to the courts and agencies might be higher still.<sup>201</sup> *In limine* hearings can take days, the opinions are often lengthy, and they tax the parties' and courts' resources.<sup>202</sup> At the same time, the benefits of the regulatory-*Daubert* proposal seem the most dubious.<sup>203</sup>

cost-effectiveness of the good-science reforms is also unclear. For example, information need not always be of the highest quality, and failure of the good-science reforms to take this into account— other than in a very superficial way through the "influential information" distinction—could lead to the imposition of unjustified costs on society. *Cf.* NAS, DATA QUALITY TRANSCRIPT, DAY 1, *supra* note 24, at 165 (comments of Jim Harris) (commenting on the high cost of quality information, but allowing that "some of these things[.] no matter how much money you spend[,] you are never going to resolve"). When one adds the unanticipated adverse consequences (perhaps the equivalent of risk-risk tradeoffs) that flow from implementation of the reforms, the costs might rise higher still. *See generally supra* Part III.B.1.

## C. Summary

If these worst case predictions of how agency officials might react to the good-science reforms are even close to plausible, it is likely that the reforms will make agency science worse rather than better, while simultaneously exacerbating other types of dysfunction already present in the regulatory process. But even if these multiple concerns are overly cautious, or significant problems with the quality of regulatory science have been overlooked, it is clear that in the current debates, analysis has taken a back seat to the reform proposals.

#### V

# THE REAL PROBLEM: REBUTTING A PRESUMPTION OF PROTECTION

Over the past decade, good-science reforms have not only dominated, but effectively side-tracked efforts to study and improve the use of science in public health and environmental regulation. Virtually every legislative effort to reform science-based regulation addresses only the quality of the scientific studies that underlie regulation.<sup>204</sup> But as the frenzy over the *quality* of individual studies used in regulation continues, more significant issues concerning the *quantity*, or weight, of the available science needed to justify and support protective regulation are ignored. Important science-policy questions relating to the amount of science required to justify a protective standard, and the amount needed to rebut the presumption of protection once a standard is in place, receive little attention, despite the fact that the answers to these questions are far from clear.

The quantity or weight-of-the-evidence problem originates from the difficulties in rebutting a central and arguably inescapable assumption of protective

regulation: the "protective assumption."<sup>205</sup> The protective assumption presumes that there is no safe dose for a variety of strong carcinogens and other toxins.<sup>206</sup> Existing scientific knowledge and precautionary mandates work together to support this assumption,<sup>207</sup> but it introduces two enormous difficulties for the practice of regulation. First, the protective assumption implies that the safe level for any activity or substance is zero or near zero, and this has costly implications for regulation.<sup>208</sup> In some situations, this expensive consequence of the protective assumption is avoided simply by narrowing the set of substances or activities to which the assumption applies<sup>209</sup> or by switching to a science-blind basis for setting regulatory standards, such as technology-based standards.<sup>210</sup>

Second, because of pervasive uncertainty, it is not clear when the protective assumption can be satisfactorily rebutted with additional scientific research.

This is the "rebuttal problem." While mechanistic studies and epidemiological research can sometimes support a "best" scientific guess that there is, in fact, a threshold below which a particular carcinogen is safe, this research generally remains inconclusive.<sup>211</sup> Thus, there is little scientific guidance for determining the point at which existing research satisfactorily demonstrates that there is a safe dose for a given toxin, or determining what that safe dose might be.

Much like the uneven parallel bars in gymnastics, then, the quantum of evidence needed to invoke the protective assumption is generally lower than the quantum or weight of the evidence needed to rebut the presumption once established. As a result, regulated entities work hard to keep substances out of the category of substances to which the protective assumption applies. At the same time, regulated parties might charge an agency with using "bad science" in refusing to conclude, based on the weight of the evidence, that the protective assumption has been successfully rebutted, even though this rebuttal cannot be based exclusively on science in most cases.<sup>212</sup>

The near impossibility of rebutting the protectionist assumption might explain why Justice Stevens struck down OSHA's expensive worker-protection standard for benzene and raised the quantum of evidence needed to justify a protective standard.<sup>213</sup> Discomfort with the onerous regulatory consequences that flow from the protectionist assumption also seem to lie at the heart of recent critiques of environmental regulation by Justice Breyer and other prominent scholars, who condemn agencies' tendency to over-regulate a few substances (by applying the protectionist assumption) while under-regulating or ignoring the vast majority of toxic substances.<sup>214</sup> Even the examples given by

good-science proponents reflect frustration with the low quantum of evidence needed to establish stringent regulation and the high quantum required to rebut the protectionist assumption.<sup>215</sup>

In this Part, I argue that the good-science problem is in large part a result of the disagreements over the quantity or weight of science needed to set and then rebut protectionist policies, rather than the quality of that science. The misdirected focus on the quality of science might be an accident,<sup>216</sup> although it is more likely to be at least partly deliberate. Regulated parties fare better when the focus is on the quality of scientific research, rather than the value choices undergirding protectionist policies.<sup>217</sup> Whatever the reason, only after the underlying problem is correctly diagnosed will it be productive to develop competing reform proposals.<sup>218</sup> This Part attempts to begin such a dialogue on

# A. The Rebuttal Problem

Public health and environmental mandates generally take a precautionary approach to regulation.<sup>219</sup> Because of the potential for catastrophic loss<sup>220</sup> and the inadequacies of the tort system,<sup>221</sup> environmental and public health statutes direct agencies to err on the side of protecting public health when promulgating regulations, even when information regarding the probability of harm is incomplete.

Under these protective statutes, agencies often have the initial burden of establishing that regulation is needed, but this burden is lighter than the common-law requirements for causation.<sup>222</sup> Uncertainties are generally resolved in favor of protection. This includes the adoption of conservative working assumptions, supported in part by science and in part by protectionist mandates, that there is no safe dose for carcinogens and that animals respond to toxins in ways similar to humans.<sup>223</sup> Backed by these conservative working assumptions, as long as the requisite quantum of scientific evidence (the quantum varies among statutes) suggests that there is no safe dose for a toxin,<sup>224</sup> an agency's burden is met under a protective mandate, and it may promulgate standards that ensure the requisite level of protection specified by the statute.<sup>225</sup>

The "rebuttal problem" arises in determining whether scientific evidence, often produced after a protective standard has been promulgated, successfully rebuts the assumption that there is no safe dose for a substance.<sup>226</sup> To rebut the protective assumption, a regulated entity or other party must produce scientific research that reveals either that the no-threshold assumption does not apply or that the toxin does not affect humans in ways similar to animals. Such a rebuttal, however, is likely to be incomplete because of the inability to validate this alternate evidence through human testing.<sup>227</sup> Without some artificial policy determination about when scientific evidence is sufficient to rebut the protectionist assumption under a particular statute, the protectionist assumption could become effectively irrebuttable. An agency could reasonably insist on almost definitive proof of safety before loosening a standard or allowing a product on the market.<sup>228</sup>

Congress arrived at an ingenious accommodation to the rebuttal problem in several protective statutes by circumventing science and basing pollution standards on reductions achievable through application of certain levels of pollution-control technologies.<sup>229</sup> By using technology-based standards, agencies are

able to avoid decisions about the amount of scientific evidence needed to justify or rebut a presumption of protection.<sup>230</sup>

In the remaining statutes, however, Congress provides little guidance either on the point at which evidence supports a protective standard or, more importantly, the point at which the protective assumption can be rebutted.<sup>231</sup> When is a Superfund site clean?<sup>232</sup> At what point is hazardous waste no longer hazard-

ous?<sup>23</sup> When does scientific research convince us that a congressionally listed toxic air pollutant is not really toxic?<sup>234</sup> Combining existing scientific research with the protective assumption of no safe dose, the true answer in most instances is that "clean" or "nonhazardous" will be achieved only when the presumptive toxins are eliminated, or nearly so.<sup>235</sup> Since an agency cannot insist on pristine conditions or zero pollution, however, it finds itself preoccupied with subtle adjustments to the quantum of evidence needed to support or to rebut

protective standards, with a resolution emerging (if at all) only after years of regulatory struggling.<sup>236</sup>

The absence of clear rebuttal criteria for protective standard-setting is often mistaken for bad science. The agency, it is argued, is scientifically incompetent in adhering to an overly protective standard because "good science" suggests that the presumption of protection is no longer warranted.<sup>237</sup> In truth, the disagreement is not a scientific dispute over the quality of individual studies, but a science-policy disagreement over the quantity or cumulative "weight" of the available science needed to rebut the presumption of protection. Certainly the

The court in the *Vinyl Chloride Case*, however, missed this rebuttal problem. It struck down EPA's approach to coming to terms with the problem—by promulgating technology-based standards—and returned the impossible mandate to EPA with no guidance. In the words of the court,

[h]ad Congress intended that result [of a zero standard for air toxins argued by NRDC,] it could very easily have said so by writing a statute that states that no level of emissions shall be allowed as to which there is any uncertainty. quality of each individual study is one factor in the rebuttal assessment, but that quality is a relative consideration, and its import depends on the results of the study, how it relates to other available studies, and the statutory demands for precaution.<sup>238</sup> Focusing excessive attention on assessing the quality of each individual study in fact deprives the agency of a more comprehensive method of evaluating the evidence that considers the cumulative results of all available evidence.<sup>239</sup>

## B. Institutional Adjustments to Counteract the Rebuttal Problem

Legislative and agency silence regarding how much evidence is sufficient to first support and then rebut various protective standards creates an opportunity for mischief. Not surprisingly, agencies, courts, executive branch officials, and even Congress have attempted to circumvent the rebuttal problem in several subterranean ways. In some cases, the adjustments work to heighten the standard for inclusion so that fewer substances are regulated in a precautionary way. In other cases, the adjustments adopt ad hoc rebuttal criteria that weaken protective regulation, often invisibly.

1. Raising Agencies' Initial Burden of Proof

The first and crudest approach to circumventing the rebuttal problem is simply to increase the quantum of research required to justify a protective standard. Instead of clarifying the amount of evidence needed to *rebut* a protective standard, this adjustment simply works to reduce the number of substances for which an agency is able to *support* a protective standard in the first instance.<sup>240</sup> This results in fewer rebuttal determinations because there are fewer protective

standards to rebut.

The most notorious example of this approach is Justice Stevens's interpretation of OSHA's mandate in the *Benzene Case*.<sup>241</sup> Concerned that absent judicial intervention, workplace safety standards could be exceedingly costly because of the protectionist mandate and impossible rebuttal,<sup>242</sup> Justice Stevens interpreted the Occupational Safety and Health Act in a way that increased the amount of evidence required for the agency to justify a standard.<sup>243</sup> This increase in the agency's burden of proof ensured that fewer standards would be promulgated, thus substantially reducing the occasions on which the rebuttal problem would arise. Legal scholars have questioned the correctness of Justice Stevens's interpretation.<sup>244</sup> Nonetheless, it has remained influential in interpreting the quantum of scientific evidence needed to promulgate protective standards—not only under the Occupational Safety and Health Act but under other protective mandates as well.<sup>245</sup>

Congress and the executive branch have also attempted to raise the burden of proof for agencies under protective mandates, thereby reducing the number of difficult rebuttal determinations. The good-science reforms, along with a small graveyard of unpassed regulatory reform bills, impose various quality checks on agency science that cumulatively serve to raise the burden of proof

that must be met to justify protective standards.<sup>246</sup> In fact, under some rejected regulatory reform bills, agencies would have been required to support proposed standards with economic studies showing they were cost-justified as well as with a variety of elaborate risk evaluations.<sup>247</sup> Agencies and the White House, particularly under administrations that favor deregulation, have also interpreted agency authority in ways that have increased the level of scientific evidence needed to justify regulation.<sup>248</sup> Under these internal directives, agencies must ensure that their science is not only of high quality, but also of sufficient magnitude or quantity, before "rushing" to regulation.<sup>249</sup> These initiatives conflict with the spirit and purpose of protective mandates.<sup>250</sup>

Increasing the quantum of evidence needed to justify regulation still leaves the rebuttal problem untouched. While these initiatives serve to reduce the

number of standards promulgated, once a protective standard has been justified, it is still onerous and effectively irrebuttable. This then leads to the overand under-regulation problem that troubles Justice Breyer and other regulatory scholars.<sup>251</sup> In the case of substances for which there is considerable research suggesting a hazard, agencies can still regulate stringently, in some cases defaulting to a presumptive standard of zero. In other cases, in which the evidence does not meet the high threshold for what is required to justify a protective standard, there will be no regulation whatsoever.

2. Cost-Benefit Analysis

Cost-benefit analysis requirements present an economic approach to rebutting a zero or near-zero standard for a presumptive human carcinogen by demanding that the benefits of ensuring protection exceed the costs of imposing a protective standard.<sup>252</sup> Although there are many legitimate criticisms of loosening protective standards based on such economic valuations, theoretically the idea of rebutting the precautionary assumption with economic-based factors has some appeal.

The science-related problems arise, even if one is willing to tolerate the valuation of human lives (which many are not), in lumping carcinogens and other hazards whose risks can be quantitatively approximated with hazards whose risks cannot.<sup>253</sup> Since use of cost-benefit analysis to rebut protective regulation depends, by definition, on quantification of risks and benefits,<sup>254</sup> risks

and other harms that cannot be quantified are generally ignored.<sup>255</sup> As a result, only a fraction of the risks posed by a substance might be counted in a costbenefit analysis. For example, neurological, hormonal, and developmental harms are often ignored in cost-benefit analysis because their risks cannot be quantified.<sup>256</sup> Protective policies can look quite expensive when there are few quantitative benefits to monetize, and protective regulations sometimes fail cost-benefit tests for precisely this reason.<sup>257</sup>

The use of cost-benefit analysis to rebut and sometimes to justify protective standards is mandatory under a few statutes.<sup>258</sup> Under one provision of the Toxic Substances Control Act ("TSCA"), EPA is actually required to support its regulations with a cost-benefit analysis that effectively raises the agency's burden of proof to the point at which most protective regulatory actions fail.<sup>259</sup> Under several other statutes, cost-benefit analysis remains a tool for rebutting the presumption of protection: after an agency justifies a protective standard,

opponents must show, with a cost-benefit study, that less protection is warranted given the costs and benefits of the standard.<sup>260</sup>

The most prevalent use of cost-benefit analysis occurs informally, typically under an executive order requiring cost-benefit analyses for all economically significant rulemakings.<sup>261</sup> In this setting, cost-benefit analyses are used to reorder agency priorities or to stall or foreclose some protective rulemakings.<sup>262</sup> The legality of using such analyses for protective standard-setting is questionable.<sup>263</sup>

### 3. Rudderless Rebuttal Decisions

Agencies appear to make the majority of their rebuttal decisions on a caseby-case basis. Most of these decisions are made independently, without the benefit of an over-arching set of rebuttal guidelines. Indeed, there is little indication that agencies make any effort to ensure consistency in making rebuttal decisions from one standard to the next.

This individualized approach has proved useful to agencies in escaping the scrutiny of courts and other critical onlookers.<sup>264</sup> Since the courts struck down OSHA's heroic efforts to develop universal principles for protective standard-

setting,<sup>265</sup> OSHA and other agencies that want to avoid similar outcomes in the future focus on only one hazard at a time, supporting decisions with highly technical records that do not purport to provide consistency from case to case.<sup>266</sup> Indeed, in some cases judicial review not only encourages agency decisionmaking to be "rudderless," but actually increases regulatory incoherence, in large part through unhelpful rulings on rebuttal determinations.<sup>267</sup> For example, in *Chlorine Chemistry Council v. EPA*,<sup>268</sup> the D.C. Circuit struck down EPA's zero-

standard for chlorine in drinking water, finding that the conservative assumptions supporting the standard had been rebutted by the "best available" evidence. Yet the court gave EPA no guidance for determining the point at which scientific evidence is sufficiently robust to rebut a conservative assumption or for weighing the rebuttal evidence in reaching a new standard.<sup>269</sup>

Agencies might also find that individualized rebuttal decisions are easier to navigate through the checks and balances of the political system than decisions made in a more systemic and open manner. OMB staff and hostile congressmen usually do not have time to extract policy judgments from individualized, technical rebuttal decisions.<sup>270</sup> Indeed, the more opaque an agency's explana-

269. The Fifth Circuit's opinion in Corrosion Proof Fittings v. EPA, 947 F.2d 1201 (5th Cir. 1991), provides a similar, but less obvious reversal of EPA's rebuttal determinations under TSCA. In Corrosion Proof, the court raised a number of evidentiary barriers to the agency's effort to ban asbestos under the Act. Id. Yet, even if injecting this added confusion into the agency's approach to rebutting regulatory activities under TSCA is legally accurate or at least prudent, it is flatly inconsistent with the appellate courts' interpretation of the rebuttal approach under the virtually identical mandate of FIFRA. tion of its rebuttal determination, the more likely the regulation will survive second-guessing from outside reviewers.<sup>271</sup>

It is thus no surprise that under some protective mandates, agencies gravitate toward individualized rebuttal determinations that can appear inconsistent when viewed as a whole.<sup>272</sup> EPA's Superfund cleanup decisions have been notoriously variable, leading not only to a lack of predictability,<sup>273</sup> but to arguments that wealthier communities enjoy cleaner cleanups than poorer communities because of their political clout and greater resources for participation.<sup>274</sup> Professor McGarity has found that the rebuttal determinations made for pesticidespecific food tolerances under the Food Quality Protection Act are inconsistent, and that some tolerances violate the explicit objectives of the statute.<sup>275</sup> EPA has no uniform criteria for assessing the point at which ambient standards for air or water pollutants can deviate from the protective assumption.<sup>276</sup> In fact, the absence of coherent rebuttal principles under section 109 of the CAA was the primary complaint of the D.C. delisting air toxins also appeared to proceed without any unified criteria for determining when the no-threshold presumption is ultimately rebutted. Similarly, EPA's review of existing toxic substances under TSCA lacks central principles for determining the appropriate testing requirements for suspect chemicals.<sup>278</sup> Finally, the agency's increased reliance on negotiated rulemaking and related forms of consensus-based regulation indicate that ad hoc, case-by-case decisionmaking might be EPA's preferred alternative for reaching rebuttal determinations in a number of circumstances.<sup>279</sup>

While making rebuttal decisions on a case-by-case basis has allowed agencies to make substantial regulatory progress, this progress has not been costless. These individual determinations have in some cases compromised or even conflicted with protective statutory mandates, have obfuscated underlying policy decisions, and have proved effectively unreviewable for most interested onlookers, especially those who have relatively few resources and little technical expertise.

# C. Reform

The scope and pervasiveness of the rebuttal problem might prove too great for comprehensive reform. Ideally, though, a system-wide reform should be implemented to ensure consistency and better opportunities for the public vetting of critical policy decisions. The remainder of this section puts incremental reforms to the side and sketches the contours of a large-scale transformation.

# 1. Defining the Problem

The first step towards large-scale reform is an accurate characterization of the problem. To this end, more work must be done to study the rebuttal prob-

lem under various protective statutory mandates. Professor McGarity's work on the implementation of FQPA provides an excellent model of the kind of indepth research that can be done to better understand the rebuttal problem.<sup>280</sup> Other studies of agency decisionmaking under protective mandates provide similarly valuable insights about the rebuttal decisions, although some studies might need to be updated or focused more specifically on the agency's rebuttal determinations.<sup>281</sup>

2. The Steps for Reform

If additional research confirms the existence of the rebuttal problem, the agencies' task is relatively straightforward: They must specify rebuttal criteria. To be done properly, this requires three separate steps, though the first might be adequate in many circumstances.

a. Statute-specific interpretations of rebuttal requirements. Agencies must first provide a general statement of how they interpret each mandate with respect to the quantum of evidence needed first to justify and then to rebut the protective working assumptions.<sup>282</sup> Each statute-specific interpretive statement must provide an indication of how precautionary the statute is with respect to rebuttal, as well as how the protective mandate compares with other statutes.<sup>283</sup> After the evidentiary demands of a protective mandate are interpreted in narrative terms, they can then be translated from general evidentiary requirements into technical specifications.

b. Technical criteria for rebuttal. In the second step, agencies should specify the kind of research needed to justify and rebut the protective standards under individual regulatory programs.<sup>284</sup> In listing toxins as hazardous substances under EPCRA, for example, EPA has developed technical specifications that effectively establish the quantum of science required to justify (but not rebut) a listing decision.<sup>285</sup> While these specifications could be more detailed, they are nevertheless a strong effort toward technically delineating the agency's burden of proof.<sup>286</sup>

For rebutting a presumption of protection, a similar checklist could be devised, although more weight-of-the-evidence judgments would need to be made in determining whether particular protective assumptions had been rebutted.<sup>287</sup> These rebuttal criteria could specify the general types of research that help to rebut the protectionist assumption for categories of substances, along with some indication of the level of certainty required for such a rebuttal under a given statutory program.<sup>288</sup> Technical specifications for rebuttal could also include the establishment of a "rebuttal process" that specifies the types of review available and the opportunities for notice and comment.

*c. Peer review of individual rebuttal determinations.* Under limited circumstances, science advisory boards could be used to review agency rebuttal determinations.<sup>289</sup> These boards could provide one of two services. First, they could review agencies' general, statute-specific scientific criteria for rebutting protective regulations.<sup>290</sup> Second, in extraordinary cases, the boards could review

agency rebuttal determinations for individual substances before rulemakings on those substances are final.<sup>291</sup> With respect to either service, these boards would make their rebuttal determinations in accordance with agency interpretations of the applicable statute.<sup>292</sup> Care would have to be taken, however, to ensure that the peer-review process does not intrude upon the substantial policymaking required in making rebuttal determinations.<sup>293</sup>

### 3. The Form of Reform

Expecting agencies to voluntarily detail the criteria they use when making rebuttal decisions is naive. The pervasiveness of the rebuttal problem suggests that, as an institutional matter, clear rebuttal criteria are either unimportant to agency survival or could actually work to impede an agency's ability to achieve its regulatory objectives. Indeed, a general lesson that emerges from studies of protective regulations is that most institutional actors benefit from keeping policy choices opaque rather than transparent, especially when the policies are controversial.<sup>294</sup> The more transparent the underlying issue becomes, the more likely the decision will become controversial, attract comments, and be challenged through political or judicial review.<sup>295</sup>

Realistically, pressure on agencies must come from the outside to encourage them to provide well-defined rebuttal criteria. Executive branch initiatives could improve the situation, but legislation would seem to be the most stable and comprehensive method of forcing agency change. For example, the reform legislation could encourage, but not require, agencies to establish explicit inclusion and rebuttal criteria for standards promulgated under individual protective mandates. Agencies' failure to develop these dual criteria would not be grounds for judicial review, but once agencies did develop these policies, the

criteria would be a final action subject to judicial review.<sup>296</sup> To give agencies the incentive to develop these policies, Congress could provide rewards. For example, Congress could specify that all individual regulations promulgated in a way that is "not inconsistent"<sup>297</sup> with the agency's inclusion or rebuttal criteria must be upheld by the courts unless a standard has no conceivable basis in fact or law.<sup>298</sup>

Whether there is sufficient political interest to coax Congress into passing such legislation is less clear. As described, regulated entities enjoy both gains and losses from the current, multi-faceted approach to protective regulation.<sup>299</sup> If a cross-section of stakeholders take interest in the problem, however, Congress might enjoy political gains from providing more systematic directions on the amount of science needed to rebut protective standards.<sup>300</sup>

Less direct, but potentially more realistic, a constellation of stakeholders with differing interests might appreciate the benefits of clearer rebuttal criteria and exert pressure on the agencies or the White House for reform. Agencies already have the vague statutory direction and the needed interpretive authority; outside pressure on the agencies might be all that is needed to effect a complete reform. Industry and national environmental groups have united in the past to recommend legislative changes, although admittedly only in relatively unique circumstances. *See, e.g.*, Rena I. Steinzor, *The Reauthorization of Superfund: Can the Deal of the Century Be Saved?*, 25 Envtl. L. Rep. (Envtl. L. Inst.) 10,016 (Jan. 1995) (describing how industry and environmental groups drafted consensus legislation to reauthorize CERCLA, legislation that was not ultimately passed into law). Industry will need to be convinced, and this might be impossible. Cost-benefit and perhaps even case-by-case approaches to rebutting protective standards might offer more benefits to industry than a clearer and more consistent approach.

### 4. Summary

Whatever the mechanism for accomplishing reform, the result could bring substantial benefits to the regulatory process. First and foremost, identifying more concrete inclusion and rebuttal criteria would provide fairer and more consistent regulatory outcomes. Without clear guidelines, agency staff enjoy nearly complete discretion in promulgating protective standards and other regulations. The resulting standards sometimes deviate from statutory goals or administration policy in ways that escape notice.<sup>301</sup>

Second, clarifying the inclusion and rebuttal criteria would help focus the issues for judicial review and ultimately reduce the variability in the outcome of such review. In part because the underlying issues—the standards for inclusion and rebuttal—have been ignored in various challenges, the courts of appeals have taken wildly different approaches in their review of protective rulemakings.<sup>302</sup> In some cases, the agency receives great deference with regard to its regulatory decisions; in other cases the court reviews the agency's scientific determinations in tedious detail; and in still others, the court second-guesses agency policy decisions as if they were predominantly technical. Without explicit guidance from Congress or the agencies, this erratic review of agency science is forgivable. Establishing explicit standards for protective regulation should go a long way in providing courts with the guidance needed to isolate the true issues in dispute.

Third, since inclusion and rebuttal criteria must be based on the level of protection specified under individual protective mandates, the rebuttal reform embraces, rather than ignores, authorizing statutes. As discussed above,<sup>303</sup> this refocusing on original statutory goals represents a marked improvement over the varied adjustments that have emerged over time. Many of these adjustments not only ignore statutory mandates, but directly conflict with them.

Finally, when it is recognized that the core problem in the use of science in regulation concerns the *quantum* of evidence necessary to justify and then overturn protective regulation, rather than simply the *quality* of individual studies, the problem is clarified as being in large part a science-policy question: that is, when is the accumulation of evidence enough to justify the acceptance of a lower level of protection? This clarification will provide much more meaningful opportunities for an attentive public to contribute to the regulatory process.

#### VI

#### CONCLUSION

As their name implies, the "good science" reforms tend to focus exclusively on the quality of agency science. A close look at much of the public health and environmental regulation put in place over the past three decades suggests,

however, that the real problem is not with the quality, but the quantity of science needed to justify and support protective regulation. Rather than direct administrative attention toward reviewing individual studies and determining whether they are scientifically acceptable, as the good-science reforms do, the rebuttal problem refocuses attention on addressing the issue of when the cumulative weight of the evidence is enough first to justify, and then to rebut, a protective policy. Only after the rebuttal criteria are clarified will the contributions of science to regulation become more transparent and accessible.
