Dear Pat:

In recent years, both the Congress and the Presidency have upheld the increased observance of human rights by all countries as a principal goal of American foreign policy. Sections 116 and 502B of the Foreign Assistance Act of 1961, as amended, in particular attempt to delineate the relationship between American security and development assistance and human rights conditions.

Given our mutual interest in affirming the importance of human rights considerations to the allocation of American foreign assistance and the conduct of American foreign policy, I am concerned that our human rights commitments not be abandoned by the Reagan Administration. I am asking for your immediate help to prepare for this possibility. Specifically, I wonder if you can provide me a legal memorandum detailing the interpretation of Section 502B and other human rights statutes your office has applied in policy implementation. Such a memorandum will be vital to those of us in the Congress who will be striving to continue efforts to promote international observance of human rights. We both know that State Department counsel in the Carter Administration and the Reagan Administration can deduce very different meaning from the same statutory language.

I very much appreciated the briefing you provided in Congressman Bonker's office the other day as well as the summary you sent me summarizing existing statutes. I will be grateful if you can supply a definitive legal memorandum interpreting each of those laws. Thank you again for your assistance. You have been an inspiration to a very worthwhile cause. Best wishes in your future endeavors.
