Modest Means Program: A reduced fee program (not free) for simple family law issues. You must be screened for income eligibility. If an attorney referral is made, the lawyer will re-screen for eligibility.

ASSISTED PRO SE: (Pro Se means "to act on your own behalf")

Lawyers help with forms and documents. You appear in court on your own. Getting this type of help can be faster.

Free assisted pro se legal services:

This FREE program offers help to prepare legal documents for divorces, protective orders, modifications, and related matters. The client attends court on their own. Call (800) 374-HOPE (4673) or apply online.

Provides FREE legal services to low-income clients who need help to pursue their family law case on their own. Call Tuesdays and Thursdays 9:00 AM-5:00 PM and tell them you are seeking 'pro se' assistance.

Reduced Fee assisted pro se legal services

4. Lawyer Referral Service Limited Scope Family Law Program (512) 472-8303, https://austinlrs.com

This is a reduced-free program (not free) for Do-It-Yourself family law. If you are representing yourself with a family law case, lawyers can be hired to assist in a limited way. They can help with: Coaching, Reviewing documents, Discovery, Representing you in single hearings. This program is not free, but you pay for the single tasks the attorney performs at their hourly rate—this is much less than paying attorney fees for the whole case.
