# **Application Instructions**

#### **Regular Decision Admission**

To be considered a timely applicant, you must:

- 1. take the Law School Admission Test (LSAT) no later than February's test administration (For 2014-2015 LSAT or Credential Assembly Service (CAS) registrants, LSAC will automatically report the results of all LSATs in your file, including cancellations and absences, since June 2009);
- 2. register with the Law School Admission Council (LSAC) for the Credential Assembly Service (CAS)\*; and
- 3. if you are a nonresident applicant, submit your completed paper application with the \$70 nonrefundable application fee to the Law School, postmarked by March 1. Texas residents are eligible to receive an application fee waiver during the 2014-2015 admission year.

\*All applicants presenting U.S. undergraduate credentials must register for the LSAC Credential Assembly Service (CAS) for transcript evaluation. Applicants presenting foreign undergraduate credentials may register with CAS or have their transcripts evaluated using the Application for Evaluation of Foreign Credentials or World Education Services (WES) as described in The University of Texas School of Law 2014-2015 Admissions Bulletin.

**Note:** Applicants for binding **Early Decision Admission** must take the LSAT no later than September's test administration. Paper applications must be postmarked by November 1. Applications submitted after the deadline will be considered for Regular Decision Admission. Please note that the Early Decision (ED) admission program is binding. An applicant admitted under the Law School's ED program must immediately withdraw pending law school applications from further consideration, as well as decline any other admission offers. An ED applicant will be required to submit an enrollment deposit and Letter of Intent (LOI). If an ED applicant does not submit the deposit and LOI within the allotted time, the admission offer will be withdrawn and the applicant will no longer be considered for enrollment during the current admission cycle. **All applicants who elect to apply under the ED program must complete the ED Binding Admission Agreement portion of this application.** 

### **Provisions 1 and 2**

Most applicants will have an undergraduate degree or will receive one before enrolling in law school and will therefore select Provision 1. Only an applicant who will be within six (6) semester hours of completing all requirements for a baccalaureate degree at the time of enrollment will select Provision 2. The Dean for Admission may declare this applicant eligible for admission upon the condition that the applicant earns the baccalaureate degree before beginning the last year of law study.

### Dual Degree applicants must also apply to the appropriate graduate program separately.

- 1. **Resume**: Please provide a resume detailing any significant vocational, avocational, extracurricular or community activities; graduate work or degree; honors and awards; any service in the Armed Forces; job descriptions and major areas of responsibility, along with location (city and state) and dates of employment; publications or other information that you believe the Admission Committee should consider in evaluating your application. Your resume may not exceed three (3) typewritten pages.
- Personal Statement: Your personal statement should give the Admission Committee insight into your character and experiences. Please

#### **Optional Attachments**

1. **Statement of Economic, Social, or Personal Disadvantage**: The Law School is interested in learning of any significant disadvantage that an applicant may have encountered or endured. Such disadvantage might take different forms, e.g., an applicant's challenges as a first-generation college graduate; an applicant's struggle with a serious physical or mental disability; an applicant's encounter with discrimination based on race or ethnicity, religion, sexual orientation, gender identity, and/or national origin; or an applicant's limited educational opportunities due to geographical or other restrictions. The committee believes factors such as these may provide additional insight into an applicant's academic potential. Ordinary predictive measures for academic success might be of less value if prior performance has been partly the result of a disadvantage. Optional statements should be limited to one page each. The statement of economic, social, or personal disadvantage may be combined with the personal statement; the personal statement should then be entitled, "Combined Personal/Economic, Social, or Personal Disadvantage Statement." The combined statement may not exceed three (3) typewritten, double-spaced pages with a minimum font size of 11 points.

- 2. **Undergraduate Performance**: If your academic performance for one or more semesters was markedly different from that of other semesters, please explain. Please make any other comments about your college transcript(s) or your preparation for college that you believe will help the Admission Committee in evaluating your application.
- 3. **Standardized Test Performance**: Candidates sometimes seek to establish that their academic potential is inaccurately reflected by standardized tests or that one LSAT score is more representative than another. If you believe this to be true in your case, please explain.
- 4. Letters of Recommendation/Evaluations: Letters of recommendation (LORs) and evaluations, while not required, are strongly encouraged. You may submit no more than three letters, or two letters and one evaluation—for a total of three items—which should be submitted directly to LSAC. For further information concerning letters of recommendation/evaluations, please refer to the online instructions for LORs and evaluations at <u>LSAC.org</u>.



# **Character and Fitness**

Applicants are advised that there are character, fitness and other qualifications for admission to the state bar, which may vary from state to state. We encourage all applicants, prior to matriculation, to determine what those requirements are in the state(s) in which they intend to practice.

Because of the high ethical standards to which lawyers are held, the failure to disclose an act or event such as the ones described below is often more significant, and leads to more serious consequences, than the act or event itself.
