This letter is to announce that the Aviation Law Section of the State Bar of Texas is accepting applications for the 2023 Aviation Law Section Scholarship. Every year, the Section awards a scholarship to a student who has an interest in aviation law. This year the scholarship is in the amount of \$5000, thank you to the matching donations made by the firms listed below. All applicants will also become members of the Aviation Law Section for one year at no cost to the applicant.

Students who apply must be in good standing at their law school, join the Aviation Law Section of the State Bar of Texas (we will enroll them), and express a desire to practice in aviation law. Each student will submit a brief discussing a recent aviation case decision. The top five briefs will be posted on the Section's website with credit to the authors.

The winning brief will be announced at the State bar Annual Meeting. The scholarship recipient, along with a law-school professor of the recipient's choosing, will be invited to attend our Section Meeting to receive the scholarship and give a brief presentation on the case he or she analyzed, and then be invited to attend dinner the night before with members and friends of the Section Council.

We invite you to share this information and the application with your students and ask that you encourage your students to apply. We look forward to this year's applications!

Application Timeline:

- May 1, 2023 – Submissions due
- May 19, 2023 – Selection of top three applicant submissions .
- May 29, 2023 – Announcement of winner
- TBD – Presentation of scholarship award at Texas Bar Annual Meeting

Application Guidelines:

- The applicant must be a **law student** in good standing with his or her school who has an interest in practicing aviation law.
- The applicant must be a **member of the State Bar of Texas Aviation Law Section**, or must fill out the attached application to be **automatically enrolled** for free.
- The applicant will submit a brief of **500 words or less** covering an **aviation case opinion** that was **decided between 2020-2022 that you think is important for our industry**.
- The brief must be submitted in **PDF form** via email to Kerry Adams (kadams@bellnunnally.com) by **May 1, 2023**.
- Applications will be judged on the following criteria:
 - Technical writing skill, including compliance with the Blue Book and Green Book;
 - Flow of narrative;
 - Applicability of case selected to aviation law as a whole; and/or
 - Interest in aviation law.
