The [Fall Interview Program](#) welcomes employers to recruit 2Ls, 3Ls, domestic and foreign-trained LL.M.s, as well as recent graduates (up to one year after graduation) for summer clerkships or postgraduate positions. Scheduled interviews for this program will be awarded by 100% employer selection and may be conducted in-person at our Law School or virtually on our web-based platform, TEX – Powered by 12Twenty. Interview dates are scheduled on a first-come, first-served basis.

The [Mock Interview Program: Public Sector](#) provides students with valuable interviewing experience while offering attorneys an opportunity to meet our students in a one-on-one setting. Each 30-minute mock interview (20-minutes in length followed by a 10-minute review) will be held from 9:00 a.m.-noon and 1:00-5:00 p.m. (CT). Mock interviews will be held in-person at the Law School (virtual options available). Lunch will be served. Space is limited to 15 employer schedules and are scheduled on a first-come, first-served basis. Each organization is limited to one schedule for this program.

### **Recruiting Policy Reminder**

Please take a moment to review our [Recruiting Policies for Public Sector Employers](#) as it pertains to recruiting our first-year students (Part B, Sections 2-4):...employers should not seek application materials from, interview, or make offers to our first-year students before November 1. Deviations from this guideline may be permissible pursuant to the circumstances of the employment situation, including the necessity of earlier application dates to allow sufficient time for required background checks. After November 1, interview appointments should be established for a mutually convenient time that minimizes interference with class attendance and disruption of candidates' studies. All offers to our first-year students for summer employment should remain open for a reasonable time.
