Books & Media Search

UT Libraries catalog search of the libraries' physical and electronic collections. Advanced Search options include search filters for Author/Creator and Subject. This search does not include books held by the Tarlton Law Library, which has its own <u>catalog search</u>.

Articles & More Search

Use this search to find full text articles, e-book chapters, etc. from UT Libraries. Advanced Search options include search filters for Author/Creator and Subject.

Databases Page

A list of all UT Libraries databases. Narrowing options include Subject (e.g., Law) and Database Type (e.g., Newspapers and Newswires). Below are a select list of UT Libraries databases that may be especially helpful. HeinOnline in particular is an excellent resource for locating scholarly articles on the law.

HeinOnline

HeinOnline is a legal research platform that includes thousands of legal periodicals and typically begins with the first issue of each journal. To search HeinOnline's collection of legal periodicals, select Law Journal Library from the homepage. Advanced Search options include a search filter for Author/Creator. Additionally, journals may be browsed by subject or author. To view all current Texas Law authors on HeinOnline, go to the Browse By options at the top of the Law Journal Library main page, select Author Profiles, then select University of Texas at Austin School of Law. Next, click on a particular author and scroll down to view their articles.

Nexis Uni

Nexis Uni provides university-wide access to legal resources, including law journal articles that typically go back to the 1980s or 1990s (go to the Legal tab at the top of the page, then from Content Type, select Law Reviews & Journals). Nexis Uni also provides access to news articles. The Content Type option under the Legal tab includes a Legal News option.

Academic Search Complete

Provides access to more than 5,300 full text periodicals, including 4,400 peer-reviewed journals. The database also provides indexing and abstracts for more than 9,300 journals and 10,900 publications including monographs, reports, and conference proceedings. Publications may be searched by author.

JSTOR

JSTOR provides access to more than 1,000 leading academic journals from the humanities, social sciences, and sciences. It also includes select academic monographs and other materials.

Newspaper Source Plus

Provides access to millions of articles from newspapers, newswires, and news magazines. Search options include searching by author or subject.

Texas ScholarWorks

Texas ScholarWorks provides open access to research and scholarship from The University of Texas at Austin. To narrow to university faculty and researchers, select UT Faculty/Researchers Works from the homepage.

Journals Search

The UT Libraries Journals Search allows users to find a journal, newspaper, or magazine by title.

Catalog

Search the Tarlton Law Library's physical collection, as well as select online resources. The Advance Search options include the ability to search by author or subject.

Databases Page
